Objectives



- Encouragement of Small and Medium Enterprises (SMEs) to engage in research and innovation activities,
- ✓ Strengthening cooperation between enterprises and knowledge intensive organizations,
- Supporting SMEs to develop innovative solutions in order to address challenges or problems they face,
- Exploitation of academic research by the industry through the provision of advisory research and innovation services,
- Creating the appropriate frame for cooperation, and increasing private expenditure in Academic and Research Organisations, and
- ✓ Mitigating the challenge many SMEs face, to exploit schemes supporting research and innovation.









Basic Principles



- ✓ RIF offers to interested SMEs, «Innovation Vouchers» which are «redeemed» by organisations that will provide them with research and innovation services.
- Simple proposal submission procedure, short timeframes for evaluation and announcement of results, as well as quick project implementation and direct problem solving.











General Call Information

- ➤ Call Budget: €310,000
- ➤ Maximum Funding Per Project: €10,000 (VAT is not eligible. Beneficiaries are responsible to pay the VAT to the knowledge intensive organisation)
- Funding Intensity: 85% (beneficiaries should cover 15% of the services' cost from own resources)
- > Duration of Project Implementation: Up to 6 Months
- Announcement Date: 14 May 2024
- > Deadline: Open Call until 09 October 2024, 13:00, or until budget exhaustion
- Co-funded by the EU Recovery and Resilience Facility

Funding will be awarded as a one-off payment, in the form of the Commission Regulation (EU) 2023/2831 of 13 December 2023 on the application of Articles 107 and 108 of the Treaty on the Functioning of the European Union to de minimis aid.











Beneficiaries / Conditions for Participation (1)

- Host Organisation (HO) of a project must be a Small or Medium Sized Enterprise (SME) which has at least four (4) and up to twenty-nine (29) full time employees
- Applicants should be productive enterprises which can justify sales and turnover according to their audited financial statements
- Applicants should be **«autonomous enterprises»**
- Each enterprise may receive funding as HO, only in one Project
- Enterprises that have received funding as HOs by the RIF, in previous projects in the frame of the RESTART 2016-2020 Programmes, excluding «Participation in International Brokerage Events» Programme are not allowed
- The participation of the same enterprise as HO and Knowledge Intensive Organisation, in different proposals in the frame of the present Call, is not allowed











Beneficiaries / Conditions for Participation (2)

Knowledge intensive Organisations can be:

- Organisations from Cyprus (Research Organisations, Academic Institutions, or Enterprises) which have been funded as Host Organisations/Coordinators for the implementation of research and innovation activities:
 - ✓ by the RIF in the frame of the RESTART 2016-2020 Programmes (excluding «Innovation Vouchers» or «Participation in International Brokerage Events » Programmes), or
 - ✓ by the EC's Framework Programmes (Horizon 2020, Horizon Europe), and
- Accredited organisations by the Cyprus Organisation for the Promotion of Quality which possess the appropriate laboratory/experimental equipment to conduct measurements, tests and/or analyses, may also participate as KIOs.











Beneficiaries / Conditions for Participation (3)

- The Project Coordinator (PO), Beneficial Owners, Shareholders and Directors of the HO cannot be employees, directors, beneficial owners, or shareholders in the KIO, or be up to third degree relatives with a Director, Beneficial Owner, or Shareholder of the KIO
- The members of the Project Team from the KIO declared in the Project Proposal cannot be employees of the HO, or be up to third degree relatives with a Director, Beneficial Beneficiary, or Shareholder of the HO











Project Activities (1)

Acquisition of <u>external services</u> for the following:

- ✓ Contracted Research,
- ✓ Measurements, tests and analyses,
- ✓ Access to research/laboratory infrastructures, and
- $\checkmark\,$ Design and development of prototype.











Project Activities (2)

The Innovation Voucher <u>cannot be used</u> for:

- o Personnel training,
- o Purchase of equipment,
- o Purchase of software / configuration of software (off the shelf solutions),
- Development of common software and mobile applications such as websites, e-commerce, accounting systems, ERPs, etc,
- Marketing or branding of products,
- Usual business consulting services (i.e. preparation of business plans), accounting or legal services,
- Consulting services related to compliance with standards/regulations, literature research, and definition of specifications for equipment purchasing, and
- Market Research.

Proposal Submission

Proposals are submitted through the Research and Innovation Foundation's IRIS Portal (<u>https://iris.research.org.cy</u>). The Project Proposal consists of the following parts:

- 1. Part A General Information & Budget (electronic form (fields) to be completed online)
- 2. Part B Technical Annex Application Form (document to be uploaded on the IRIS Portal in PDF format).
- **3. ANNEX III Call Specific Information** (documents to be uploaded as Annexes on the IRIS Portal in PDF format, duly completed and signed):
 - (a) **Declaration** of the Host Organisation,
 - (b) Declaration for confirmation of **non-debts to state Authorities**,
 - (c) Single Undertaking Declaration, and

(d) **Audited Financial Statements** of the HO for the previous fiscal year (N-1) or the year preceding it (N-2), where «N» is the Call announcement year.

Evaluation / Project Selection

- Evaluation: Upon submission of each proposal an internal evaluation procedure is carried out by RIF staff (first-in-first-served), according to the Call requirements.
- Project Selection: By order of submission to the RIF (non-competitive procedures apply) on condition that proposals have been deemed eligible for funding according to the Call requirements and the following are duly justified:
 - ✓ The need of the enterprise to receive research and innovation services and the expected results (deliverables).
 - ✓ The relevance of the proposed services with the core activities of the enterprise.
 - ✓ The enhancement of the capacity of the enterprise for research and innovation and the potential of the company to adopt research and innovation practices.
 - ✓ The enhancement of enterprise's competitiveness as a result of its increased capacity to develop innovative (new or significantly advanced existing) products/services/processes, and/or innovative solutions to address problems the enterprise faces.
 - ✓ The benefit for the Knowledge Intensive Organisation as a result of the cooperation with the beneficiary enterprise.
- Eligible proposals are selected for funding, until the total requested funding of approved
 Proposals, equals the total Call budget.



Completion

Upon the completion of the assigned work the HO submits to the RIF:

- A brief Report using the «Progress Report» document
- A «Payment Request» which includes the original invoice issued by the Knowledge Intensive Organisation (KIO)
- ✓ Provided that the necessary conditions are met, the approved funding will be released to the Knowledge Intensive Organisation
- ✓ Approved Funding amounts to 85% of the KIO's cost
- ✓ If the total cost, according to the invoice issued, is lower than the value of the Innovation Voucher then the payment will correspond to the actual cost
